Rule 4(m) of the Federal Rules of Civil Procedure provides:

[if] a defendant is not served within 120 days after the complaint is filed, the court on motion or on its own after notice to the plaintiff must dismiss the action without prejudice against that defendant or order that service be made within a specified time. But if the plaintiff shows good cause for the failure, the court must extend the time for service for an appropriate period. Fed. R. Civ. P. 4(m). In cases involving a plaintiff proceeding in forma pauperis, the United States Marshal, upon order of the Court, shall serve the summons and the complaint. 28 U.S.C. § 1915(d); Fed. R. Civ. P. Marshal for service of the summons and complaint and [he] should not be penalized by having his

action dismissed for failure to effect service where the U.S. Marshal or the court clerk has failed to Walker v. Sumner, 14 F.3d 1415, 1422 (9th Cir. 1994) (internal quotations and citation omitted), abrogated on other grounds by Sandin v. Connor

effect service is aut Id. at 1422 (internal quotations and citation omitted). However, where a pro se plaintiff fails to provide the Marshal with accurate and sufficient information e dismissal of the unserved defendants is appropriate. Id. at 1421-1422. Here, the Marshal forwarded the service packet to a special investigator at the California Department of Corrections and Rehabilitation. The special investigator was unable to locate Defendant Rufino. Plaintiff shall be provided with an opportunity to show cause why Defendant Rufino should not be dismissed. Fed. R. Civ. P. 4(m). If Plaintiff either fails to respond to this order or responds but fails to show cause, Defendant Rufino shall be dismissed from this action. /// /// /// /// /// 1 2 3 4 5 6 7 8 9 10 11 12 13 14 15 16 17 18 19 20 21 22 23 24 25 26 27 28

Based on the foregoing, IT IS HEREBY ORDERED that:

1. Within thirty (30) days from the date of service of this order, Plaintiff shall show cause

why Defendant Rufino should not be dismissed from this action; and 2. The failure to respond to this order or the failure to show cause will result in the

dismissal of Defendant Rufino from this action.
